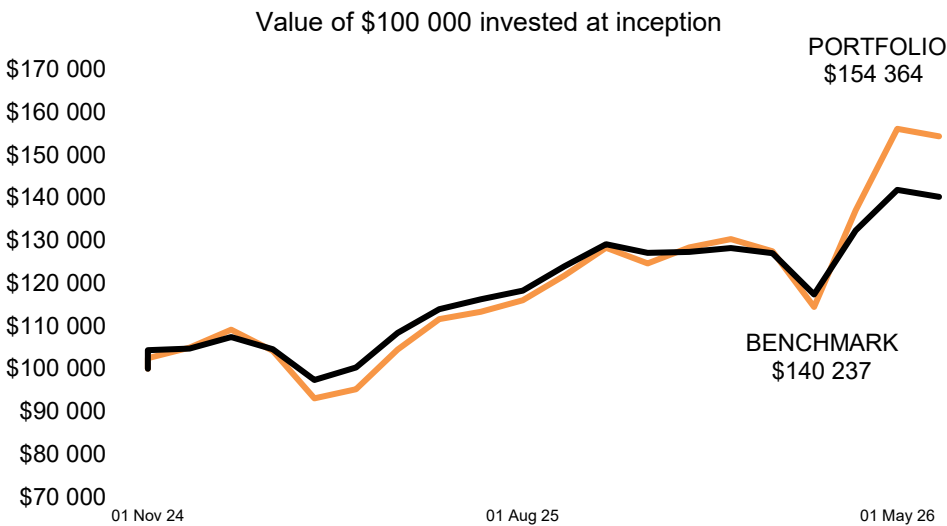

The portfolio combines the weighting of the benchmark with a risk-averse investment philosophy of purchasing companies trading at the largest discount to their intrinsic value, in order to be benchmark cognisant. The portfolio is designed to beat the benchmark returns over a 10-15 year cyclical basis. The portfolio ranges between 10 and 30 equity holdings. This portfolio is suitable for institutional investors who would like to have their funds permanently invested in equities throughout the full business cycle. If the institutional investor would like their wealth protected before recession, this will have to be discussed with the investment manager.
